Short-term Mission Policy – 3 months or less:

- LifePoint members participating in LifePoint sponsored short-term trips are eligible for a maximum subsidy of up to 50% of your trip expenses.
LifePoint members participating in trips not sponsored by LifePoint are eligible to apply for a maximum subsidy of 25% of your trip expenses, if needed.
LifePoint members leading a LifePoint sponsored trip are eligible for a subsidy of up to 100% of trip expenses.
Applications for a subsidy should be submitted to the Mission Plan Group at least 60 days before funds are due.
Under normal circumstances this assistance is available once every three years, but applications are considered on an individual basis. Non-members are not eligible for subsidies.
